### **Announcing a New Mount Olive/Goldsboro Connector With a Greyhound Stop Upon Request**

Beginning on July 2, 2018 the Goldsboro-Wayne Transportation Authority (GWTA) will offer a new connector service between Mount Olive and Goldsboro which will include a stop (upon request) at the Greyhound Station on US Highway 117. GWTA will also offer a new circulator service in Mount Olive. The pilot project is funded for one year to determine if there is enough ridership to continue the service. The service will be funded through a partnership between the North Carolina DOT, GWTA, and the Town of Mount Olive.

#### **Mount Olive/Goldsboro Connector Service**

Connecting services from Mount Olive to Goldsboro will depart from the Walmart on Highway 55 at 7am, noon and 5pm. Connecting services from Goldsboro to Mount Olive will depart from the GWTA transfer center at 5:30am, 6:30am, 11:30am and also at 4:30pm. The Mount Olive/Goldsboro Connector may stop at the Greyhound Station on US Highway 117, if you request in advance. Connections are also available for AMTRAK and Greyhound at the GWTA Transfer Center.

#### **Mount Olive Circulator Service**

Weekday service will circulate through the town on an hourly schedule via Church Street and Breazeale Avenue beginning at the Walmart on Highway 55 at 6am and ending at 5pm. There are no weekend services. There are twenty-two (22) signed stops conveniently located throughout the town of Mount Olive, including stops at the Walmart, Piggly Wiggly, the Carver Center, Rose's, Mount Olive Pickle Company and the Bob Denning Superstore. Look for the GWTA bus stop signs located along the route to catch a ride. If you request in advance, the Mount Olive Circulator may come to you.

#### **Fare to Ride**

A trip on the Mount Olive Circulator is only \$1 per person

A trip on the Mount Olive/Goldsboro Connector is only \$3 per person

The service will be **FARE FREE the week of July 2 – July 6!** However, there will be no service on July 4.
