Recessed Board Meeting
Minutes

Mayor Pro-Tempore Barbara Kornegay called the meeting to order at 3:00 P.M. Those in attendance per roll call of Mayor Pro-Tempore Barbara Kornegay, Commissioner Delreese Simmons, Commissioner Tommy Brown, Commissioner Danny Keel, Vicky Darden, Town Attorney Carroll Turner and Town Clerk/Administrative Assistant Sherry Davis.

Mayor J. Jerome Newton was unable to attend today's meeting due to an emergency. Commissioner Tommy Brown made a motion to grant him an excused absence. Commissioner Danny Kell seconded, and the motion passed 5-0.

Mayor Pro-Tempore Babara Kornegay welcomed everyone to the meeting.

Commissioner Vicky Darden presented our invocation and Commissioner Tommy Brown led us in the Pledge of Allegiance.
