Special Called Board Meeting
Minutes

Mayor Pro-Tempore Barbara Kornegay called the meeting to order at 10:00 A.M. Those in attendance per roll call were Mayor Pro-Tempore Barbara Kornegay, Commissioner Delreese Simmons, Commissioner Tommy Brown, Commissioner Vicky Darden, Commissioner Danny Keel, Town Attorney Carroll Turner, Interim Town Manager Glenn Holland and Town Clerk/Administrative Assistant Sherry Davis.

Commissioner Danny Keel gave the invocation and Commissioner Tommy Brown led us in the Pledge of Allegiance.

Mayor Pro-Tempore Barbara Kornegay read the Conflict-of-Interest Statement; there were no conflicts.

Mayor Pro-Tempore Barbara Kornegay requested a motion to approve an excused absence for Mayor Jerome Newton who was unable to attend today's meeting. Commissioner Tommy Brown made the motion to approve an excused absence for Mayor Jerome Newton. Commissioner Vicky Darden seconded, and the motion passed 5-0.

Mayor Pro-Tempore Barbara Kornegay requested a motion to approve today's agenda. Commissioner Danny Keel made the motion to approve today's agenda. Commissioner Tommy Brown seconded, and the motion passed 5-0.

Mayor Pro-Tempore Barbara Kornegay then discussed Action Memo – 09-26 - Consider Approval of the TRC Companies Grant Administration & Engineering Agreements for CDBG Infrastructure Grants 19-I-4203 & 24-I-4203. She asked if anyone had any questions, then requested a motion to approve. Commissioner Delreese Simmons asked who oversees the grant projects. Interim Town Manager Glenn Holland advised TRC Companies & Town Staff. Town Clerk Sherry Davis stated the state funding agency also oversees. Mayor Pro-Tempore Barbara Kornegay asked if there were any questions then requested a motion to approve. Commissioner Tommy Brown made the motion to approve Action-Memo – 09-29. Commissioner Danny Keel seconded, and the motion passed 5-0.
